In consideration for being allowed entry into and participation at 2022 Genesis Invitational (the "Event"), I hereby acknowledge the following by my signature above:

I acknowledge that at all times, I am a volunteer for the organization listed above, allowed to work thru Facility Concession Services, Inc. dba Spectrum Catering, Concessions, and Special Events ("Spectrum"), and I am not acting as an employee of Spectrum.

Pursuant to my participation as a volunteer, I recognize that there are certain risks and possible bodily or personal injuries and damages that one may sustain through such participation in the Event.

RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

COVID-19 RELEASE AND INDEMNITY UPDATE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.
